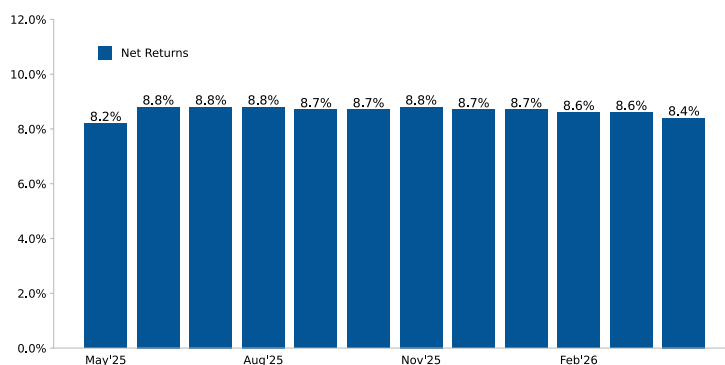

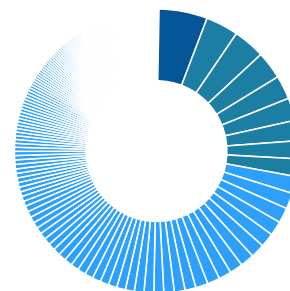
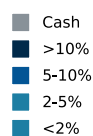

Trailing 12-Months Net Returns³

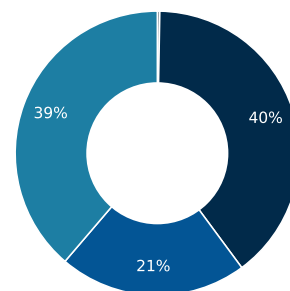
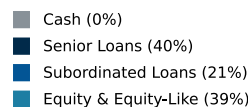


Portfolio Construction⁵
