#### **Target Market Summary**

The Fund primarily invests in a concentrated portfolio of microcap Australian and New Zealand companies. This product is likely to be appropriate for a consumer seeking capital growth and to be used as a small component of their portfolio where the consumer has a medium investment timeframe and a high risk/return profile.
